# February Meeting Minutes

## Our General Meeting

convened at Sinnott's Sand Bar 206 E Lincoln St, Papillion, NE 68046 with 6PM Meal provided by Sinnott's consisting of Cheeseburger and coleslaw and \$2 draws. Meeting began at 6:30 PM.

After starting the meeting with prayer followed by Pledge of Allegiance we had **2 perspective members** introduce themselves to the division.

**Meals** Monday Lunch (February at Brazen Head and March at Railway) was mentioned along with the Tuesday Supper on March 9th at Jam's in the Old Market.

Phil Bauersachs brought up the **general meeting the plan for a St. Patrick's Day** quarantine concert (possibly to be called St. Pat's day Shamrock Party). Phil has talked to the management of Aloft (215 South 181st St., Omaha NE 68022) who will help drum up attendees. Entertainment will be Pipes and drums with an honor guard to start the night, Monsignor to say a prayer followed by Dowling to play for 4 hours, and Irish dancers. Food will be from Just Good Meats. Aloft will set aside some rooms at a special rate and have the concert multicasted to the rooms. Price will likely be around \$120-\$150 with food. Several hospitality rooms will be open. Beer and liquor will be sold by Aloft but will change out the beers to some Irish beers (Guinness

and Harp). Phil will be setting up a whiskey tasting. To make some money we will be charging around \$15 for a ticket and meal to just watch the concert. A silent auction is also being put together. Involving the LAOH in this event will be explored. If the weather is bad we can move the concert to Aloft's ballroom. The media will be looked at for advertising our sponsors. Motion was presented and passed at the meeting to provide a budget of up to \$1500 for this quarantine concert.

March 17th was set as the date for the **General John O'Neill ceremony**. Show at 9:40 AM and ceremony at 10 AM.

Tim Donegan presented the **Treasurer's Report**. There was a loss of \$4500 in 2020. The plan of the Endowment Committee and the Board is to hire a certified planner to manage our mutual fund account.

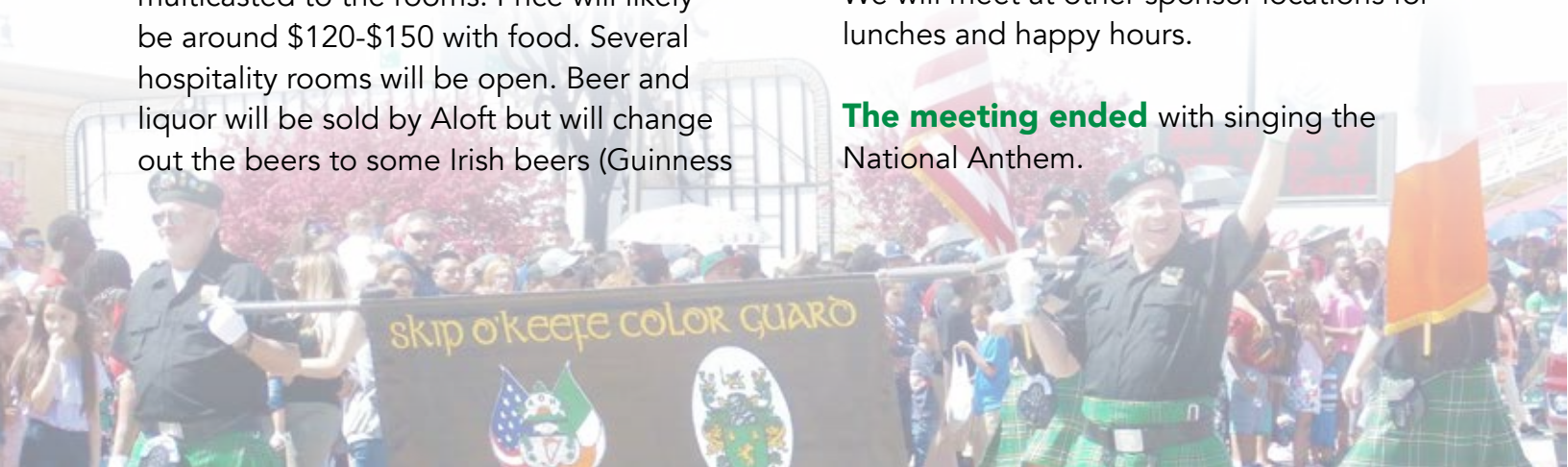
## We will be meeting at Sinnott's Sand Bar for every AOH General Meeting.

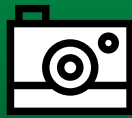
